CHAPTER 123, ENTITLED NOISE, OF THE CODE

**123-4. Enumeration of unnecessary noises.**

**D. Construction or repair of building.**

**(1) The erection, including excavating, demolition, alteration or repair of any building other than between the hours of 8:00 a.m. and 5:00 p.m., every day except Sunday and the following listed Federal holidays: New Year’s Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day; except in case of urgent necessity in the interest of public health and safety and then only with a permit from the Borough Inspector, which permit may be granted for a period not to exceed three (3) days while the emergency continues and which permit may be renewed for periods of three (3) days or less while the emergency continues.**

**All other terms and conditions of this chapter shall remain in effect.**
