**WHEREAS, Ovarian cancer is called the "silent killer" because its symptoms are often vague or subtle; and**

**WHEREAS, Ovarian cancer is the fourth leading cause of cancer death among women and the leading cause of gynecologic cancer death in the United States; and the risk of developing it increases with age and a family history of this disease. Other risk actors include a history of endometrial colon or breast cancer and obesity. Because early detection is crucial in treating ovarian cancer and its symptoms can be difficult to identify, women should consult their doctors about personal risk factors, early warning signs and screening options, and**

**WHEREAS, during National Ovarian Cancer Awareness Month, we remember those who have lost their lives to ovarian cancer and we honor the courage and strength of those who continue to fight this disease. We also recognize the dedicated medical professionals and researchers whose timeless efforts help provide a brighter, healthier future for women, and**

**WHEREAS, each year, more than 22,000 Americans are diagnosed with the disease and approximately 16,000 die from it; and**

**WHEREAS, if detected in its early stages, survival from ovarian cancer is 90-95 percent. Yet the five year survival rate for the disease is only 28 percent, because it is so difficult to detect early; and**

**WHEREAS, the Kaleidoscope of Hope Foundation (KOH), a local non-profit group co-founded by ovarian cancer survivors Gail MacNeil of Chatham Township and Lois Myers of Harding Township, raises funds for research and to increase awareness of the disease and its symptoms, and wishes to remind the public that September is Ovarian Cancer Awareness Month by tying teal ribbons on trees throughout the town; and**

**NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the Borough of Avon-By-The-Sea declares its support for National Ovarian Cancer Awareness Month in September, 2009.**
